#### Designation - Regulations

- □ Articles 123 and 124 of CPR Regulation 1303/2013
- □ Aim "to ensure that the MA and CA have the necessary and appropriate MCS set up from the start of the period to ensure they can fulfil the responsibilities assigned to them under Articles 125 and 126 CPR"
- Article 124(1) Member State must notify Commission of designations before first interim payment application
- Assessment to be carried out by IAB

#### Guidance

- Guidance for the Commission and Member States on a common methodology for the assessment of management and control systems in the Member States
  - □ Annex 1 Key Requirements for MA and its IB(s)
- Guidance for Member States on Designation Procedure
  - □ Annex 3 "Checklist for assessing the compliance....with the designation criteria"
- Annex III of Regulation 1011/2014
  - "Model for the description of the functions and procedures in place for the managing authority and the certifying authority"
  - Not a template, but a useful list.

#### **Designation Criteria**

- Annex XIII of CPR Regulation 1303/2013
- Internal Control Environment
  - Organisational Structure, Allocation of Functions, Separation of Functions
  - Framework for delegation of tasks to IBs
  - Procedures for reporting and monitoring irregularities
  - □ Plan for allocation of human resources
- Risk Management
  - □ Framework for conducting an appropriate risk management exercise

#### **Designation Criteria**

- Management and Control Activities MA procedures
  - Grant applications, project selection
  - Management verifications
  - Processing payments
  - Data collection and storage
  - Accounting
  - Anti-fraud
  - Audit Trail and Archiving
  - Management Declaration, Annual Summary etc
  - Provision of document re conditions of support

#### **Designation Criteria**

- Management and Control Activities CA procedures
  - Certifying Interim Payment Applications
  - Drawing up Accounts
  - Adequate Audit Trail
  - Procedures for ensuring information on verifications from MA
- Monitoring MA Procedures
  - Support work of PMC
  - Drawing up AIRs
- Monitoring CA Procedures
  - Monitoring results of management verifications and audits

#### MCS Description

- "Forms the basis for the audit work to be carried out by the IAB"
- Management and Control System (MCS) Description
  - Summary setting out information on all of the designation criteria.
  - □ Information on MA, CA, AA and IBs, including Organisational Structures.
  - Refers to other procedure documents.
  - Detailed section on Information Systems
    - Data Collection Procedures
    - Description of IT System
